DRR-CCA Clubs initiated by RedR India In order to promote youth-led resilience, RedR India launched Disaster Risk Reduction (DRR) and Climate Change Adaptation (CCA) Clubs Network - An initiative to institutionalize resilience education and action across campuses. While the University Grants Commission (UGC) had advised higher educational institutions to establish DRR Clubs; RedR India broadened the vision by integrating Climate Change Adaptation (CCA), recognizing the close linkages between disaster and climate risks. The program was launched on the International Day for Disaster Risk Reduction, i.e., on 13th October, 2025, by Shri Krishna S. Vatsa, Hon'ble Member, National Disaster Management Authority (NDMA), in the presence of experts, academicians and representatives from various humanitarian organizations. The response has been highly encouraging, with more than 150 colleges and universities already registered with RedR India to

13<sup>th</sup> October 2025, the occasion of the International Day for Disaster Risk Reduction (IDDRR), was celebrated by the Chaitanya Jyothi Welfare Society (CJWS) along with the Fisherfolk community members, local youth, SHG groups, Panchayat representatives, and school children in Koduru, TP Guduru Coastal Village, Nellore District, Andhra Pradesh. Speakers including Mr I SrinivasaRao, Director- CJWS,IAG President, A.P; Mr Dr.G.V. Ravikumar, Disaster Management Expert and Director JC Trust and Ms Anusha - RDO - Nellore District and Community Leaders were present. In coastal regions like Nellore District, where fishing is the main livelihood, communities are highly vulnerable to cyclones, floods, storm surges, and sea-level rise. To mark this global event, CJWS organized a community-level awareness and preparedness program with fisher folk of Koduru, located along the coast of Nellore District -AP to raise awareness among fisher folk about disaster preparedness and early warning systems; to promote safe fishing practices and sustainable livelihood options; to strengthen communitybased disaster management (CBDM) at the village level and to commemorate IDDRR and align local action with the Sendai Framework (2015-2030). Local experts and DRR community practitioners explained early warning systems, emergency evacuation routes, and the importance of life jackets and radio communication. Demonstration on Safety Equipment: Practical demonstrations on using life buoys, ropes, and first-aid kits were

given to the participants. Fisher folk youth discussed local hazards, coping mechanisms, and community action plans for cyclone preparedness. Increased community understanding of cyclone early warnings and evacuation planning. Strengthened linkage between fisher folk, local Govt stakeholders and duty bearers. Promoted collective responsibility for coastal ecosystem conservation by involvement of communities. Empowered women and youth to play active roles in disaster response teams. The IDDRR celebration successfully highlighted the importance of community resilience and preparedness among coastal populations. This was the fourth in a series of nine workshops across NCR cities aimed at promoting sustainable road design and dust control practices under CAQM's Standard Framework for cleaner, healthier urban environments. The Faridabad workshop engaged officials and engineers in sessions on sustainable street design, dust abatement, and DPR preparation, while the Gurugram event featured citizen-oriented IEC activities, including a "walk-shop" on Haryana's first model street with walking and cycling tracks, plantation, and bioswales. The 2025 Global Multidimensional Poverty Index (MPI) report by UNDP and the Oxford

Poverty and Human Development Initiative (OPHI) reveals that nearly 8 in 10 people living in multidimensional poverty -887 million out of 1.1 billion globally, are directly exposed to climate hazards such as extreme heat, flooding, drought, or air pollution. Released ahead of COP30 in Brazil, the report highlights how environmental risks intensify existing inequalities and trap millions in cycles of vulnerability. South Asia and Sub-Saharan Africa emerge as global hotspots. The findings call for urgent climateresilient poverty reduction and adaptation strategies, along with global cooperation and

The 2025 NDCs Synthesis Report by UN Climate Change provides an updated overview of global climate commitments under the Paris Agreement. It finds that countries are strengthening their NDCs with improved quality, credibility, and broader coverage- most now include economy-wide emission targets, and 73% incorporate adaptation and resilience measures. The report also notes growing attention to Loss and Damage,

gender equality, and just transitions, reflecting a more holistic approach to climate action. However, while global emissions are projected to decline by about 10% by 2035, this progress remains insufficient to meet the 1.5°C goal. It urges nations to accelerate implementation, scale up support for vulnerable countries, and link climate action with

The report warns that adaptation finance for developing countries is far below what's needed to cope with worsening climate impacts. Annual costs are estimated at US\$310-365 billion by 2035, while current flows stand at just US\$26 billion, making needs 12-14 times higher than available funds. At this rate, the goal of doubling adaptation finance by 2025 will not be met. The private sector could contribute around US\$50 billion annually if supported by stronger policies. While most countries now have national adaptation plans and projects underway, growing financial constraints threaten future progress. The report urges both public and private finance to scale up urgently without adding to vulnerable nations' debt burdens. It emphasizes that closing the adaptation gap is vital to safeguard

million meet only 0.2% of the estimated needs for 2030. This brief proposes a minimum allocation floor of 0.08% of GDP for developed-country contributions to the FRLD. By aligning contributions with responsibility, capability, and vulnerability, the approach ensures that historically high emitters and financially stronger nations provide sustained, grant-based support, while protecting vulnerable countries from further debt burdens and strengthening global climate solidarity. The Purple Fest 2025, held in Goa from October 9th to 12th, stood out as a beacon of inclusion, accessibility, and celebration for persons with disabilities. This international festival, organized by the Government of Goa and the Ministry of Social Justice and Empowerment in collaboration with United Nations India, firmly placed the ideals of dignity and participation at the heart of its events. The fest welcomed over 10,000 delegates from 25 countries and drew more than 50,000 visitors, making it one of the world's largest gatherings dedicated to disability inclusion and empowerment. At its core, Purple Fest was a vibrant confluence of art, culture, and advocacy where inclusion was not just a theme but an experience lived by all attendees. Art installations, musical and dance performances by persons with disabilities, interactive workshops, and inclusive sporting events created a platform that honored diversity, accessibility, and the creative potential present in every community. The festival's highlights included the recognition of "Purple Ambassadors," inspirational figures who champion accessibility, and a strong focus on sharing best practices in inclusive education and employment. Through participatory forums, the fest facilitated dialogue on universal design and accessible public spaces, encouraging wider adoption of Goa's pioneering "Purple Movement" model by other states. The impact of this year's Purple Fest extended well beyond its four days, inspiring renewed commitments to social justice, policy action, and community-driven change in the pursuit

resilience today. Drawing from the Global Assessment Report on Disaster Risk Reduction 2025's contrasting futures - "Generation Jolt" and "Generation Regeneration" - the Sprint underscores how present choices determine whether the world moves toward escalating crises or sustainable recovery. By channeling youth creativity and scientific insight, the initiative reinforces the message that investing in young people is investing in resilient futures.

Global Protection Update: Protection in a Prioritised Humanitarian Response, October 2025

As of October 2025, 395 million people in 23 countries face severe protection risks, including violence, coercion, and deprivation. Crises in DRC, Myanmar, Gaza, Sudan, and Ukraine are among the most extreme, with escalating conflicts driving mass displacement and violations of rights. Climate shocks like floods and earthquakes further worsen vulnerabilities, while funding shortfalls severely limit response capacity. Despite a US\$3.2 billion appeal, only 23% has been met, leaving most needs unaddressed. The report urges that protection be central to humanitarian action, ensuring safety, dignity, and rights remain at the core of crisis response. Stronger international commitment and funding are vital to prevent further deterioration and safeguard the most at-risk

lives, livelihoods, and economies in the Global South. Read here>>



While the government had distributed ration kits, challenges related to livelihoods and economic recovery continued to persist. In Kakinada, significant crop losses were reported, and CJWS extended support by providing ration kits to affected families and assistance to farmers who had lost their crops. A Google Form had been circulated among members to collect details of ongoing and planned interventions, with submissions requested by the following day. The next coordination meeting was scheduled for the day after to review updates and progress. Emerging needs identified during the discussion included winter clothing, non-food items, school

materials, and sanitation supplies, which had become priorities in the affected communities.

Public-Private-People

were actively monitoring developments in the area. Reports indicated damage to livestock, for which HSI was expected to extend support. Inland fishing activities had been disrupted, affecting local livelihoods, and the agriculture sector had suffered extensive losses. Villages along the Krishna River were impacted by continuous rainfall, and rat infestation was reported as a secondary effect of the cyclone. ActionAid reported active engagement in Nellore district, including tribal areas, focusing on four mandals where around 50-60 villages were

Technical sessions covered Rapid Multi-Sector Needs Assessments (RMSNA), Rapid Needs Assessment methodology, and data collection using geospatial and Al tools, featuring insights from NDMA, ISRO, SDMAs, and field experts. A panel discussion on recovery and reconstruction brought together experts from NIDM, NITI Aayog, Sphere India, and others, focusing on innovative approaches like Community Certification and Self-Reporting mechanisms. The workshop concluded with key takeaways on enhancing institutional capacities for structured, transparent, and community-centered disaster

The 2025 Lancet Countdown report highlights a sharp rise in health risks linked to THE LANCET climate change, warning that millions are dying unnecessarily each year due to continued dependence on fossil fuels and insufficient adaptation efforts. Heat-related deaths have surged by 63% since the 1990s, now reaching around 546,000 per year, while extreme weather, heatwaves, drought, and climate-linked food insecurity are worsening globally. The report, produced by a global team of experts, calls for urgent action: phasing out fossil fuels, investing in cleaner energy, and placing health at the core of climate policy. It also notes that strong local leadership and city-level climate O HERVAL action are beginning to deliver health benefits, but global progress remains too slow to meet the scale of the crisis.
