VISION

To build a safer and disaster resilient India by promoting quality and accountability in humanitarian action through a principle based inclusive process of collaboration of all humanitarian actors including Government Agencies, UN Agencies, Red Cross, International, National and Local NGOs, CBOs and Communities.

MISSION

To enhance the Quality and Accountability of Humanitarian Action in India and protecting the rights and dignity of the people affected by natural calamities or conflict situations in India.

The lesson learned exercise in Uttarakhand cloud burst response coordination was one of the key achievement. The key observations and recommendations will be able to create a blueprint for the future response strategies.

We welcome our members to the first Sphere India Annual Report 2012-13. This is with sentiments of joy and gratitude that we thank your valuable contributions, inputs, suggestions, comments which have helped us achieve this essential milestone. The overall objective of Sphere India is to enhance the Quality and Accountability of Humanitarian

Action in India and protecting the rights and dignity of the people affected by natural calamities or conflict situations in India. With this objective in the year 2012-13 Sphere India pursued its overarching goals by promoting effective co-ordination, advocacy to promote disaster preparedness and response. Taking lessons from the Uttarakhand cloud burst, response coordination efforts were made to develop enriched tools in consultation with member agencies. Sphere India was primarily engaged in building the capacities of relevant stakeholders in different thematic areas throughout the year.

Sphere training of trainers was conducted in Delhi which was attended by EFICOR, CASA, Plan India, WSPA, Compassion, NCDHR, MSF, PCI Bangladesh and other state inter-agency groups. This ToT was the first one conducted using the latest version of Sphere Handbook 2011. The new training materials were used by the facilitator team as an inspiration for member agencies to incorporate in their field interventions. EMMA was organized by Practical Action Consulting Asia, Christian Aid and sphere India. This training on EMMA toolkit will equip participants to understand analyze and make better use of market system in emergency situations.

Building Capacities and identifying the role of stakeholders in Animal Disaster Management, was a new thematic area where Sphere India provided support to WAP in the form of two abstract paper presentations. Drought consultations in Maharashtra & Jharkhand were organized with support from WHH to assess the status of malnutrition and the need for conducting the Joint need assessment.

Inter-Agency Co-ordination (IAC)

Inter-Agency Coordination program is continuity of Sphere India Unified Response Strategy initiated in last phase. The program coordinates collective efforts for preparedness, response and recovery.

Objectives

- 1. Develop/strengthen State level capacities for coordination (IAGs)
- 2. Facilitate a common process for coordination of members, partners and other stakeholders for preparedness, response and recovery.

COLLABORATIVE ADVOCACY

Collaborative Advocacy program initiated in 2010 to bring focus on collaborative humanitarian advocacy

Objectives

- 1. Mobilize and sensitize different stakeholders on humanitarian principles and standards
- 2. Humanitarian advocacy during disasters for rights and entitlements of affected people focusing on excluded /marginalized and most vulnerable groups.
- 3. Policy advocacy for development of inclusive and appropriate policy.
- 4. Advocacy on silent humanitarian situations and disasters like drought, malnutrition and other extreme development situations in which people are living below minimum standards of dignity.

Key Highlights of 2012-13

- 1. Roundtable Consultation on Hunger and Malnutrition in India organized at national level to bring different stakeholders together on one platform and develop collaborative strategies for dealing with Hunger and Malnutrition in India in collaboration with National Disaster Management Authority (NDMA) and National Human Rights Commission.
- 2. 03 State level Consultation on Food & Nutrition Security were organized at Madhya Pradesh by Sphere India and Welthungerhilfe (WHH), along with local implementing partner Jan Sahas, West Bengal with implementing partner DRCSC and Jharkhand with local implementing partner PRAVAH 3. Conference on Ensuring inclusion of Biodiversity-dependent communities in
- all Preparedness, Adaptation and Mitigation measures was facilitated in collaboration with National Dalit Watch of NCDHR

Learning

- WHH efforts to bring different stakeholders together on one platform and develop collaborative strategies for dealing with Hunger and Malnutrition in India in collaboration with National Disaster Management Authority (NDMA) and National Human Rights Commission.
- Inclusion of Biodiversity-dependent communities in all Preparedness, Adaptation and Mitigation measures.

TRAINING & CAPACITY BUILDING

Program initiated in 2008 to coordinate and facilitate training and capacity building interventions of member organizations primarily focusing in the gap areas.

Objectives

- 1. Periodically analyze training and capacity needs through Inter agency process.
- 2. Collate and standardize training modules.
- 3. Coordinate/ Facilitate TOTs and build a pool of master trainers.
- 4. Coordinate need based trainings to build capacities of stakeholders at varied levels.

Key Highlights of 2012-13

- 1. 23 individuals (from PCI-Bangladesh, CHA-Sri Lanka, EFICOR, CASA, Plan India, WSPA, Compassion India, NCDHR, IDF, MSF and 06 State Inter-Agency Groups like Rajasthan, Uttarakhand, Orissa, Tamil Nadu, Bihar) were trained/sensitized in TOT using the latest edition of Sphere handbook (2011) in India. The training was jointly facilitated by Administrative Training Institute of State Govt. of Rajasthan, National Institute of Disaster Management, Govt. of India and Sphere India.
- 2. 05 Days Training on Emergency Market Mapping and Analysis (EMMA) being organized at New Delhi, India. This important training is being jointly organized by Practical Action Consulting Asia, Christian Aid and Sphere India.

 3. Two Abstract paper presentations were given at the WSPA Event at FICCI on Role of Capacity Building and Role of Stakeholders Animal Disaster Management. The aim was to build sufficient capacities within the community and other stakeholders, to be able to better perform the roles and responsibilities for disaster risk reduction and emergency response, pre and post disaster

Learning and way forward

- A roadmap was proposed for preparing a technical team including the vertinary personel, paravets etc. to build specific capacities for actions related to livestock in different contingency situations like for Earthquake, Flood, Fire, Storm, Road Accident and CBRN disasters.
- Uses of new training materials for Sphere introduction, Protection and humanitarian charter in humanitarian response.


