

Minutes of Meeting | 2nd Meeting on Livelihood and Rehabilitation 16th of March, 2020 | Delhi Violence-Response

The meeting was a follow-up meeting on livelihood and rehabilitation of victims affected by the Delhi violence was held on the 16th of March, 2020 via Skype. List of sector committee members, members participated, and the agenda of the meeting is attached in the Annex 1 and 2. The agenda wise key discussions, decisions and actions points are as below:

Agenda item 1: Updates and Way Forward

Key Discussions:

- 1.1 EFICOR highlighted their scope of current interventions extended to 3 locations across North East Delhi, having identified 40 families to provide livelihood support to. EFICOR urged for other organizations to step forward and assist in providing livelihood to the victim population.
- 1.2 SEWA informed of their work in Garhi Medhu, wherein they are providing livelihood to people. They informed that they are also targeting women who were unemployed pre-violence, and providing them with garment-making training and market access. They stressed on the importance of understanding and addressing livelihood issues faced indirectly by local residents.
- 1.3 SEWA is undertaking needs assessment in Mukund Nagar, which has 40-45 destroyed houses, and invites suggestions, if any, on their needs assessment tool. Same has been attached in Annexe 3. The report of the same shall be shared shortly.
- 1.4 Save the Children has informed that they have covered 65 households as of today.
- 1.5 Christian Aid reiterated their joint efforts with PHIA and EFICOR in providing psychosocial support and livelihood initiatives respectively.
- 1.6 It was urged that government data of victims be shared at the earliest.

Actions: 1.1 Save The Children and SEWA to share their report by 18th of March, 2020.

1.2 A follow-up meeting shall be reconvened after the reports are received and compiled by WHH, with support from Sphere India Secretariat.

1.3 SEWA to invite livelihood sector committee Members from the Meri Delhi Campaign for the subsequent meeting.

1.4 SEWA to share their internal livelihood assessment report by the End of the Day, 16th of March
