

# Minutes of Meeting | 11<sup>th</sup> of March | SDM-Office, Nanda Nagari

## Education and Protection Sector Committee Meeting | Delhi

### Violence-Response

The meeting for Education and Protection Sector Committees was held on the 11<sup>th</sup> of March, 2020 at the SDM Office- Nanda Nagari, North East Delhi. List of sector committee members, members participated, and the agenda of the meeting is attached in the Annex 1 and 2. The agenda wise key discussions, decisions and actions points are as below:

#### **Agenda item 1: Update on agencies responding on Protection Sector in NE Delhi**

##### **Key Discussions:**

- 1.1 It was noted that the displaced population is returning to Khajuri Khas area – albeit in smaller numbers. 100 children were found to not have had milk in the previous several days but that need has been satisfied so far.
- 1.2 Children are moving to Idgah Camp from Al-Hind Hospital, Mustafabad. Therefore, DCPCR-led initiative in Idgah camp needs to be substantiated through expert support.
- 1.3 2 trained-psychiatrists are reportedly undertaking needs assessment in Chand Baugh.
- 1.4 Children between the age of 6-14 are provided with regular classroom teaching, while those children identified who are above 14 years are given counselling.

- Actions:**
- 1.1 A Whatsapp group to formed of those providing psycho-social care for further coordination.
  - 1.2 Sphere India to link United Way and Helping Hands with UNICEF for the Training of Trainers being undertaken over the next few days.
  - 1.3 Nikita to inform others if organizations can send
  - 1.4 Sphere India to coordinate with NIDM for conducting training of trainers for psychosocial support.

#### **Agenda item 2: Key issues and gap analysis**

##### **Key Discussions:**

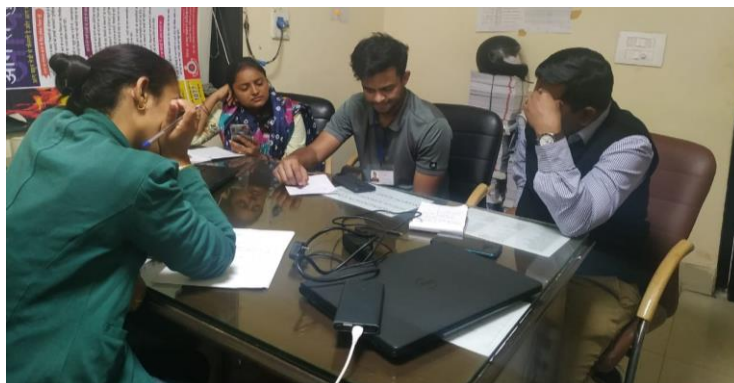
- 2.1 It was noted that over-exposure to media and NGOs has increased the trauma suffered by camp residents.
- 2.2 While Child-Friendly space should be established for every 25-30 children, there currently exists only one CFS for the 500-odd children in the camp. It was also noted that only 200-300 children are in the CFS at the Idgah camp.
- 2.3 Age-specific bracketing and subsequent care should be provided. Initiatives in Idgah camp should follow a proper module.
- 2.4 Save the Children is ready to undertake a survey in Bhagirathi Vihar.
- 2.5 Aanganwadis now-closed as a preventive measure for COVID-19 should be used as CFS once opened.
- 2.6 Idgah camp needs more councillors to provide psychosocial support for both – women and children. Each tent should have at least 2 councillors.
- 2.7 For organizations providing counselling, DCPCR has suggested that those providing support to general victims should at least have an undergraduate degree, while those suffering from excessive trauma should be addressed by someone holding a minimum of Master's degree in psychology and related fields.
- 2.8 AIIMS to provide training of trainers for providing psychosocial support – organizations are invited to attend the same.

#### **Agenda item 3: Way Forward**

##### **Key Discussions:**

- 3.1 Children between the age of 3-6 years should be provided special focus. Accordingly, Save The Children to provide 4 experts (2 male and 2 female) to the Idgah camp every day for the next 10 days in between 10:00 am -12:00pm in collaboration with DCPCR.

3.2 No needs assessment or programming has been undertaken for women and disabled population – this should be focused upon. SEWA Bharati can facilitate the needs assessment.
