The Annual Lesson Learnt Workshop 2022 was co-hosted by Sphere India in collaboration Save The Children and NCDHR on 21st and 22nd December 2022, to provide an interactive platform to different stakeholders and members to discuss the challenges, achievements, outcomes and learnings from 2022 to document the experiences, best practices for better response and preparedness for 2023 and to have a shared understanding on the way forward.

During this two day event, Sphere India commenced the sessions with annual learning and knowledge survey findings, which collated the responses from our members & IAGs. Further deliberations were made from an organizational standpoint which encompassed the voices of people on the field during the COVID-19 pandemic wherein various perspectives and experiences were shared. Following this, Save The Children also launched “ A Compendium of Case Stories: Accelerating Actions to combat humanitarian crisis amid COVID-19 Pandemic- A tell of Human Tales”. The second half of day one focused on Reflections and sharing by State IAGs, which led to critical discussions and discourse.





In response to disasters in various parts of India, SitReps were prepared and disseminated. A total of 5 Sitreps were prepared in the month of December for Cyclone Mandous, Brazil Floods and US Cold Storm. Apart from this, a pre-cyclone alert was issued on December 8, a high wave alert was issued on December 9, a flood alert was issued on December 8, and a cold wave warning was issued on December 24 and 25 after monitoring the IMD, CWC and INCOISE websites. 4 weekly alerts were also disseminated every monday morning.



Collaborative Advocacy

Engaging Faith Based Leaders to end Child, Early, Forced Marriage in Chhattisgarh

For delaying the age of marriage, an enabling and empowering eco-system is required to protect a woman's human right and prevent discrimination. The first session on "Engaging Faith-Based Leaders to end Child, Early and Forced Marriage in Chhattisgarh" was organized by USAID MOMENTUM, in collaboration with Sphere India on 8th of December. The meeting was organized with faith leaders from different religions of Chhattisgarh to protect woman's human rights, access to services, aid, and safety from violence, abuse, and exploitation by preventing earl- forced marriages. This being the first, two more similar events are lined up in the coming months.





COP 27: Updates and Debriefing for India

Sphere India team kept a close watch on the various deliberations, discussions and announcements during COP 27. These updates were collated and analysed from Indian Perspective and was shared with Sphere India Members & Network. An event "Decoding COP27: Walking Towards The Road Of Implementation" was also organised on 5th December 2022, in collaboration with CANSA, the outcomes & recommendations from the discussions during this event, was documented and thus Debriefing & Outcome Documents were prepared by Sphere India and disseminated across its members.

Prayer Meeting for the Speedy Recovery of Shri. J C Pant



In the late 90s when it was realized that the existing organizational structure for disaster management had gaps in providing a quick and coordinated response to various disaster situations, the Government of India constituted a High Powered Committee for suggesting appropriate DM Plans at the National, State, and District level which was headed by Shri J.C. Pant (retired Secretary, GoI, Ministry of Agriculture).

The critical study and report of this committee led to a major transformation in the DM ecosystem of our country and became the foundation stone for the constitution of the NDMA. Sphere India along with its members organised a web meet for the great humanitarian behind it. On the occasion of Shri J. C. Pant's birthday, a virtual prayer meeting was organised for his speedy recovery. This meeting was joined by eminent personalities from the sector.

On December 5th' 2022, with a conscious effort to take forward the discussions held at COP 27 at a National Level, Sphere India in collaboration with Climate Action Network South Asia (CANSAs), organized a hybrid event in New Delhi on "Decoding COP27: Walking towards the Road to Implementation" to understand the key discussion points of COP27, ideate on the critical way forward, and ultimately devise an action plan for India/South Asia. With participation from over 170 individuals, the event witnessed opinions, thoughts, and strategies to take forward from over 13 speakers &



resource persons representing the government, corporate, think tanks, and civil society perspectives. Presenting his remarks, Shri Kunal Satyarthi, IFS, Joint Secretary, NDMA, elaborated on Santiago Network and shared that COP27 has been a great victory as the institutional and organizational structure, along with the technological know-how and technical assistance in Loss and Damage is now ready. Prof. Anil Gupta, Head of Department, NIDM, presenting the keynote address said, "There has been a continuous flow of improvements in the policy regime in the area of climate science".

The event was thus an opportunity to put forth discussions on the key aspects of the Climate Change Conference such as Loss and Damage Facility, Roles of private sectors in climate finance, Localizing Climate Action, Mission LiFE, Fair Share and Equity concepts, amongst others. Based on the deliberations, and key discussions held at COP27, Sphere India also came out with an Outcome Document to present a strategic way forward for India in line with the key decisions adopted at COP27.

Save The Children launched a publication called " A Compendium of Case Stories" on December 21st' 2022 at the Lessons Learnt Workshop 2022, co-hosted by Sphere India and Save The Children. The event saw the unveiling of the "Compendium of Case Stories: Accelerating Actions to Combat Humanitarian Crisis amid COVID-19 Pandemic- A tell of Human Tales" and felicitation of government representatives for their contribution towards COVID-19 emergency response.

This informative document includes various case studies and stories which have been highlighted during the challenging times of the pandemic. This collection of case stories illustrates instances in which working together across sectors enables complex problems; be it healthcare, enabling learning continuity of children or ensuring adequate protection to children.



Oxfam- India Inequality Report 2022

Launched in December 2022, India Inequality Report examines the digital divide in the access and usage of ICTs and the internet has also led to an exclusionary consequence in three sectors of utmost significance: education, health and finance. In a country plagued by high socioeconomic inequality, the digitalization process cannot be posited as the panacea for the inherent challenges of the physical world. It becomes particularly problematic when half of the population neither has access to gadgets and the internet or the technological know-how to move to a digital environment. In such circumstances, the digitalization process becomes unequal, favoring the digitally connected while excluding the rest, and in certain cases, exacerbating the already existing inequalities. 
The IAG Gujarat annual meet was organized on December 23rd 2022, wherein 75 IAG members participated in the event and presented the annual report and discussed about next year actions.


Climate Change and Earthquake Exposure in Asia and The Pacific



This study analyzes the exposure of energy and transport assets in Asia and the Pacific to climate change and earthquake hazards and highlights how multi-hazard assessment can help strengthen the resilience of crucial infrastructure.


Geolocating and undertaking a multi-hazard assessment of more than 30,000 infrastructure assets, the study identifies significant risks across the region with three-quarters of the assets exposed to four or more hazards. It notes that multi-hazard assessment and an understanding of the potential impacts of these hazards need to be systematically integrated into the planning, design, and financing of infrastructure upgrades and maintenance. COP27 Outcome Document for India




COP27 Outcome Document for India encloses key discussions, announcements, pledges by India and plans for implementation ahead. It is drafted on the basis of pre and post COP27 consultations, organised by Sphere India with CANSAs and other partners. Further, Sphere India also kept close watch on the critical deliberations happening as part of all thematic days, and the outcomes were documented from India's perspective, which has also been shared and summarized in this document. Updates from Government

G-20 Presidency 2023

India assumes the G20 Presidency on the 1st of December 2022 from Indonesia and will convene the 'G20 Leader's Summit' for the first time in India in 2023. A nation deeply committed to democracy and multilateralism, India's G20 Presidency would be a water-shed moment in her history as it seeks to play an important role by finding pragmatic global solutions for the wellbeing of all, and in doing so, manifest the true spirit of 'Vasudhaiva Kutumbakam' or the 'World is One Family'.



Disaster Risk Reduction Under The G-20 Framework



During India's G20 Presidency, it has been raising concerns that hold global good. One such concern includes building a resilient world that is equipped to deal with disasters and climate change. In this regard, as part of its unique contribution as G20 President, a new working group on disaster risk reduction will be constituted. India's G20 Sherpa, Amitabh Kant in a media briefing said that a new work stream on disaster risk reduction has been established under India's Presidency to encourage collective work, multi-disciplinary research and exchange of best practices on disaster risk reduction.

The Energy Conservation Bill 2022



The Energy Conservation (Amendment) Bill, 2022 seeks to mandate the use of non-fossil sources, including biomass and ethanol, for energy and feedstock, along with the use of green hydrogen and green ammonia. The bill also proposes to enhance the scope of the Energy Conservation Building Code and bring large residential buildings within the ambit of the energy conservation regime.

Kerala State Action Plan on Climate Change



The Kerala State Action Plan on Climate Change 2023-2030 (Kerala SAPCC 2.0) released identifies nine districts as most vulnerable in terms of overall inherent vulnerability and envisions mitigation strategies for avoiding approximately 57,000 ktCO₂ from various sectors by 2030. In India, at the national level, climate change planning synthesizes the SAPCCs. The SAPCC Revision Team coordinated the entire planning exercise at the Directorate of Environment and Climate Change, Government of Kerala.

The Action Plan has adopted improved climate model projections and vulnerability assessments to suggest strategies, actions, and monitoring mechanisms.
