


Fostering Climate Resilience in India: the Catalytic Role of CSR Initiatives -21 November 2024



Carbon Pricing Metrics: Exploring GEDSI in Climate Resilient WASH



The report "Exploring GEDSI in Climate Resilient WASH" examines the "Building Climate-Resilient WASH for Vulnerable Populations" project in Jaipur's urban slums. It focuses on integrating Gender Equality, Disability, and Social Inclusion (GEDSI) principles into WASH governance, benefiting marginalized groups. The project improved access to water and sanitation for over 69,000 people, enhanced climate resilience, and strengthened local governance. Initiatives include menstrual health programs and traditional water management practices. While progress has been made, challenges in infrastructure maintenance and resource mobilization remain. The report offers recommendations for ensuring sustainable and inclusive WASH services in vulnerable communities. Read More >>

Empowering Vulnerable Populations - Jaipur Vaani



Jaipur Vaani is a technology-driven communication platform aimed at addressing local grievances related to WASH services in Jaipur. Part of the "Building Climate-Resilient WASH for Vulnerable Populations" project, it focuses on providing climate-resilient and socially inclusive WASH services to 74,420 people in Jaipur and Bhubaneswar. The project addresses water scarcity, sanitation, and hygiene challenges exacerbated by climate change, impacting vulnerable communities. Jaipur Vaani uses communication as both a tool for service improvement and a platform for community engagement, enhancing WASH service delivery through feedback and active participation. It empowers local populations to voice concerns, ensuring that WASH services meet their needs and are sustainable in the long term. Read More >>

These challenges disproportionately affect marginalized groups, exacerbating inequalities. The report emphasizes the importance of integrated climate action that addresses both environmental and social vulnerabilities, with a focus on poverty reduction, resilient infrastructure, and improved public health. It also highlights successful, community-driven initiatives, offering examples that can be adapted to other cities facing similar challenges. Read More>>

The Climate Finance: A Developing Country Perspective highlights key issues and recommendations regarding climate finance, with a focus on the upcoming COP29. The report discusses the need to redefine climate finance flows, emphasizing that developed countries should provide new, additional, and actual disbursements, rather than reclassifying existing aid. It stresses that public capital, especially in the form of grants or blended finance instruments, should be prioritized, along with the private capital these mobilize. The report also outlines the financial gap developing countries face, proposing that the New Collective Quantified Goal (NCQG) should aim to meet an estimated USD 1 trillion per year in external climate financing by 2030. COP 29 Baku, Azerbaijan



At the COP29 negotiations held in Baku, India emphasized the critical need for climate finance to remain distinct from investment goals set by developed nations. Climate finance, which is pivotal for supporting developing countries in transitioning from fossil fuels to renewable energy, had to uphold its essence as a targeted provision and mobilization commitment, as outlined in the Paris Agreement.

"Climate finance cannot be redefined as an investment target. It is a unidirectional commitment from developed to developing nations, as explicitly mandated by the Paris Agreement," stated Naresh Pal Gangwar, India's lead negotiator, on Thursday, November 14, 2024. The statement, later made public by the Union Environment Ministry on November 15, underscored India's stance that developed nations bore the primary responsibility for mobilizing these financial resources.

Meanwhile, discussions at Baku explored the mobilization of \$5 to \$6.8 trillion in climate finance by 2030, a figure critical to advancing global climate action goals

World Urban Forum 12, Cairo Egypt



The Twelfth Session of the World Urban Forum (WUF12) convened by UN-Habitat took place in Cairo, Egypt, from November 4 to 8, 2024. Returning to the African continent after more than two decades, WUF12 centred on the theme "It All Starts at Home: Local Actions for Sustainable Cities and Communities." The forum emphasized the importance of localizing the Sustainable Development Goals (SDGs) and highlighted initiatives aimed at addressing global challenges such as unaffordable housing, rising living costs, climate change, lack of basic services, and ongoing conflicts.

The event attracted a record-breaking attendance of over 37,000 participants, including representatives from national, regional, and local governments, academia, the private sector, urban planners, and civil society. Discussions focused on the critical role of local actions in achieving sustainable urbanization and improving the quality of life in communities worldwide.

Updates from Government

High-Level Committee Endorses Critical Disaster Resilience Projects for States

A High-Level Committee, chaired by Union Home Minister Shri Amit Shah, has approved a significant allocation of ₹1115.67 crore for disaster mitigation and capacity-building projects across various states. Among the approved initiatives, ₹1000 crore will be dedicated to the National Landslide Risk Mitigation project, which spans 15 states, including ₹139 crore

each for Uttarakhand and Himachal Pradesh, ₹378 crore for eight North Eastern states, and ₹100 crore for Maharashtra, with additional funds for Karnataka, Kerala, Tamil Nadu, and West Bengal. The committee also approved ₹115.67 crore for the training and capacity building of civil defense volunteers in all states and UTs, aimed at enhancing preparedness and response to disasters. These steps align with Prime Minister Shri Narendra Modi's vision for a disaster-resilient India, strengthening the country's disaster risk reduction system. Under the leadership of Prime Minister Modi and the guidance of Union Home Minister Shri Amit Shah, more than ₹21,476 crore has been released this year to support disaster management, including funds from the State Disaster Response Fund (SDRF), National Disaster Response Fund (NDRF), State Disaster Mitigation Fund (SDMF), and National Disaster Mitigation Fund (NDMF). India's Active Participation in G-20 DRRWG Ministerial Meeting



A high-level Indian delegation, led by Dr. PK Mishra, Principal Secretary to the Prime Minister, participated in the G-20 Disaster Risk Reduction Working Group (DRRWG) Ministerial Meeting in Belem, Brazil, from October 30 to November 1, 2024. The meeting resulted in the finalization of the first Ministerial declaration on Disaster Risk Reduction (DRR). Dr. Mishra highlighted India's proactive approach to DRR, focusing on key priorities such as early warning systems, disaster-

resilient infrastructure, DRR financing, resilient recovery, and nature-based solutions. He also shared insights on the Coalition for Disaster Resilience Infrastructure (CDRI), a global initiative led by India with 40 countries and seven international organizations. In addition to his remarks, Dr. Mishra emphasized India's commitment to the Sendai Framework and called for enhanced international collaboration in disaster resilience. The Indian delegation engaged in various bilateral meetings with ministers from Brazil, Japan, Norway, South Africa, South Korea, Germany, and other countries. This participation underscores India's growing leadership role in global disaster risk reduction efforts. Read More>>
